RACE 1 0-58 HANDICAP 1200 METRES:

Shortly after jumping, RUNNING ON FAITH (B Hoppo) became momentarily unbalanced after bumping with ROCKET BROTHER (C Moon) on its outside. PROPORTIONATE (K Gladwin) was inclined to lay out from about the 800 metres. Approaching the 600 metre turn, TAKEN IT EASY (R Vigar) rolled in slightly onto RUNNING ON FAITH which in turn rolled in onto PROPORTIONATE and as a consequence, WORK THE BODY (C Johnson) which was half a length back racing along the fence was momentarily tightened for room.

All riders were reminded of their obligations to ensure they are mindful of riders on their inside and in particular the 600 turn.

1ST WORK THE BODY 2ND RUNNING ON FAITH 3RD STAR DISTRACTION

RACE 2 BENCHMARK 68 HANDICAP 1100 METRES:

As the gates opened, LUCERNE VALE (K Gladwin) was a little slow into stride.

1st CATCH AS CATCH CAN 2ND ONTHEHUSSLE 3RD LUCERNE VALE

RACE 3 MAIDEN PLATE 1100 METRE:

As the gates opened, FUZZY ANGEL (B Hoppo) knuckled badly and lost some ground. Rounding the 600 turn, EDDY'S ACE (C Johnson) which was racing a little greenly was inclined to lay out.

K Connor rider of BILLYESS was found guilty of a breach of AR.137A(5)(a)(ii).

The details being that prior to the 100 metres she used her whip in the forehand manner on 9 occasions.

Stewards acting under AR.196(2) ordered that K Connor forfeit her riding fee in relation to this race.
