RACE 1 HANDICAP 1200 METRES: As the gates opened PIONEER PRINCE (B Carlile) was slow into stride after beginning a little awkwardly.

FASTER BUSTER (M Evans) had to ease off the heels of BARSTOOL (J Cameron) within the first 100 metres of the race after BARSTOOL shifted inwards.

KIRIKIRISH (D McIntosh) was ridden aggressively for most of the event and raced without cover.

SOFIE FATALE cast its off side plate during the event.

1ST BARSTOOL: J CAMERON

2ND PIONEER PRINCE: B CARLILE (A)

3RD SCAT SINGER: C MOON

RACE 2 0-58 HANDICAP 1200 METRES: As the gates opened PRINCESS ELLIE (S Evans) was slow into stride.

DROVER'S LAMENT (C Moon) was inclined to lay out over the first 200 metres subsequently bumping with SNAPPY GENERAL (B Carlile) on its outside.

NO TAX ON CASH (C Johnson) rolled in about the 1000 metre and brushed with SNAPPY GENERAL which inturn tightened DROVERS LAMENT on its inside.

Both NO TAX ON CASH and NORTH VEGAS (D McIntosh) raced wide with no cover.

At about the 200 metre SNAPPY GENERAL shifted in sharply onto PRINCESS ELLIE.

SNAPPY GENERAL was inclined to lay in over the final stages whilst NO TAX ON CASH shifted in over the concluding stages.

1ST DROVERS LAMENT: C MOON

2ND NO TAX ON CASH: C JOHNSON

3RD PRINCESS ELLIE: S EVANS

RACE 3 CLASS B HANDICAP 1100 METRES: NOTFORGIVEN (D McIntosh) began awkwardly and subsequently was slow into stride.

As the gates opened BLACK JOHNNIE (C Moon) was slow away.

BLACK JOHNNIE was inconvenienced at the 500 metre whilst attempting to make a run on the inside of A GLASS AND A HALF (K Gladwin).

Over the concluding stages NOTFORGIVEN rolled in and as a result BLACK JOHNNIE was tightened momentarily onto INVINCIBLE BLUE (B Carlile).

1ST INVINCIBLE BLUE: B CARLILE (A)

2ND BLAZE AID: C JOHNSON

3RD NOTFORGIVEN: D MCINTOSH

RACE 4 0-69 HANDICAP 1000 METRES: Shortly after the start ARTACUS (D McIntosh) and GAP EXPRESS (C Johnson) bumped.

1ST GAP EXPRESS: C JOHNSON

2ND CULLENARY DELIGHT: J CAMERON

3RD MISS ICELAND: B CARLILE (A)

Post-race samples were taken from all winners.

Stewards concluded an inquiry into the whip use of Jan Cameron when she rode CORPORATE ACTION in the Maiden Plate on the 13th February.

Jan Cameron was found guilty of a charge under AR1375 (a)(i)(ii) in that she used her whip in 4 consecutive strides and two extra in a forehand manner prior to the 100 metre.

Stewards ordered that Jan Cameron forfeit her riding fee for that race acting under AR196 (2).

Stewards concluded an inquiry into the reasons why licensed jockeys J Cameron and D McIntosh left the course after fulfilling their riding engagements prior to seeking the permission of the stewards as is required under AR. 91.

Both riders pleaded guilty to a charge under Rule AR.91 in that they left Pioneer Park Racecourse without the permission of the stewards.

Both riders were fined the sum of \$150.00.
