RACE 1 OPEN HANDICAP 1200 METRES:

As the gates opened, LUCERNE VALE (P Johnson) was slow into stride whilst THE GHOST (C Moon) jumped outwards bumping ALPHA GOLD (S Evans) which dipped slightly.

K Manoukian rider of CATCH AS CATCH CAN was found guilty of a charge under AR137A(4)(b) in that he used his whip in an action that raises his arm above shoulder height.

Acting under AR196(2), stewards ordered that K Manoukian forfeit his riding fee for this event.

R Bell trainer of LETS TRY LONGER was fined \$200 for presenting his runner into the mounting yard with the incorrect gear (AR140A).

1ST DIESELFUEL 2ND CATCH AS CATCH CAN 3RD LETS TRY LONGER

RACE 2 0-58 HANDICAP 1200 METRES:

As the gates opened, AQUIA CREEK (K Gladwin) knuckled and lost some ground. MISS ICELAND (E Boyd) rolled out wide rounding the home turn.

Mr K Lamprecht trainer of HE'S REELING was fined \$100 for presenting his runner late into the mounting yard for this event (AR124).

1st CALEJA 2ND MISS ICELAND 3RD GIBRALATAR MELODY

RACE 3 2YO PLATE 1000 METRE:

As the gates opened, DANGER MOUSE (M Evans) which was a little slow into stride was tightened onto I NEED A DOLLAR (C Ellis) after PERFECT PAUSE (E Boyd) jumped outwards.

Approaching the 400 metres, UNCOVERED WEALTH (S Westover) had to steady off the heels of EMJEM (K Manoukian) after that filly rolled in.

Stewards questioned J Cameron rider of LADY REMINGTON in relation to her ride on that filly over the final 250 metres.

J Cameron stated that the filly got onto its wrong leg entering the straight and as it was beginning to tire, she did not push the filly out.

J Cameron also stated the LADY REMINGTON was also going for a spell. Stewards accepted J Cameron's explanation.

1ST PERFECT PAUSE 2ND LEAVE A MESSAGE 3RD SON OF LETO

RACE 4 0-64 HANDICAP 1000 METRES:

On jumping, SWEET COUNTY (C Moon) was tightened between runners and as a result knuckled slightly whilst WORK THE BODY (C Johnson) was slow into stride. INDEE'S HOPE (S Westover) was inclined to lay out slightly from about the 600 metres.

1ST INDEE'S HOPE 2ND RAMPANT PRINCE 3RD A NIGHT IN HONKERS

RACE 5 0-70 HANDICAP 1600 METRES:

About the 250 metres, GAP EXPRESS (K Manoukian) rolled out bumping SEYMOUR SNAKE (C Moon) onto JAZZ KING (E Boyd).

1ST GAP EXPRESS 2ND EMPEROR OF THE SUN 3RD MYSTICAL BOND

RACE 6 MAIDEN PLATE 1400 METRES:

As the gates opened, both GOLDEN FELIX (C Ellis) and LOVE THE DREAM (S Evans were slow into stride.

1ST HILLBILLY RICH 2ND MINE CRAFT 3RD MAYBE JUST MAYBE

Stewards interviewed trainer Mr Mark Nyhan today in relation to him riding track work at Pioneer Park on Tuesday the 19th March without an approved safety vest.

Stewards subsequently found Mr Nyhan guilty of a charge under AR87B(1) in that when mounted on a horse he failed to wear a properly fastened safety vest the standard of which has been prescribed by Order of the Board.

Mr Nyhan was fined the sum of \$500 and notified of his right of appeal.

Stewards today interviewed trainer N Moody in relation to comments made on a social media website relating to certain racing incidents at Pioneer Park.

Whilst stewards took no action, Mr Moody was advised that his comments were of a nature that could possibly be open for question and that he should be more mindful in future of what is posted on such social media websites.
