Race 1: Tennant Security Service Trobis Maiden Plate 1000 metres

UNIVERSAL AMBITION (K Manoukian) – Slow into stride and raced wide throughout.

CUMULOUS CLOUD (T Brummell) – Raced wide throughout.

EVIL WAYS (W Kerford) – Underwent a veterinary inspection on arrival to the barriers after dislodging its rider and was passed fit to start.

GIRL HAPPY (A Spradau) - As no other rider was available, Stewards permitted jockey A Spradau to ride 1.5 kg overweight. When questioned rider explained that he was unaware he had been named to ride the mare and therefore had not attempted to lose any additional weight. Trainer Mr K Lamprecht confirmed that had tried to confirm the engagement by telephone but was unable to reach the rider or leave a message. Stewards accepted the explanation tendered.

MISS ALLIE (M Tyndall) – Rider was dislodged on route to the barriers and after being examined by Ambulance officers was subsequently cleared to ride. The filly underwent a veterinary examination at the barriers and was cleared to compete.

General: Jockey C Moon (UNCOVERED WEALTH) acknowledged a breach AR137A(5)(a)(ii) in that prior to the 100 meters he used his whip in the forehand manner on 3 additional occasions more than permitted and was fined the sum of \$200.

Race 2: Marlow, Canete & Associates Handicap 1100 metres

WHAT THE HECK (T Brummell) – Slow into stride and raced wide throughout.

MYKINDACOLOUR (W Davis) – Raced wide throughout.

Race 3: BP Service Station Class B Handicap 1200 metres

FASHION KURV (T Brummell) – Bumped with another runner on jumping. After performing poorly, a veterinary examination failed to reveal any abnormalities. Trainer reported that the gelding has a tendency to mix it's form.

ROYAL CHOICE (C Moon) – Jumped inwards on jumping bumping with another runner and when straightened overreacted and shifted outwards.

ALL DUE RESPECT (R Vigar) – Raced wide rounding the home turn and down the length of the straight.

BAD MEDICINE (W Kerford) – Inclined to lay in under pressure down the length of the straight causing its rider some difficulties in riding the gelding out fully to the finish.

Race 4: Tennant Creek Emporium Handicap 1450 metres

MAYBE JUST MAYBE (R Vigar) – Permitted his mount to shift in shortly after jumping.

KASKAR (C Moon) – Stood flat footed when start effected and lost 6 lengths. As the gelding had offended in a similar manner at its previous start, trainer Mr K Lamprecht was advised that it must compete in 2 barrier trials to the satisfaction of the Stewards prior to racing again.

FIRST LOT (W Davis) – Fractious in the barriers.

ONYA DUSTY (T Brummell) – Clipped heels and blundered near the 1400m.

General: Stewards inquired into an incident which occurred near the 1400m. Apprentice R Vigar, in the presence of licenced person in care Mr G Lefoe, was found guilty of a charge of careless riding under AR137(a). The specifics of the charge being that approaching the 1400m he permitted his mount MAYBE JUST MAYBE to shift in when not sufficiently clear of ONYA DUSTY (T Brummell) causing that gelding to clip heels and blunder. Apprentice R Vigar had his permit to ride in races suspended for a period of (2) NT race meetings to commence midnight the 16th May until midnight the 24th May. Apprentice R Vigar was advised of his right of appeal.

Race 5: Denis Staunton Memorial St Patrick's Cup 1200 metres

No incidents to report.

Race 6: XXXX Gold Tennant Creek Cup 1600m

General: Jockey C Moon (EFFCEE) acknowledged a breach of AR137A(5)(a)(i)&(ii) in that he used his whip in the forehand manner consecutively and on 2 additional occasions more than permitted prior to the 100m and was fined the sum of \$500. In assessing penalty Stewards took into account his mount won the race.
