RACE 1 0-69 HANDICAP 1100 METRES: As the gates opened, KIPPSY (J Cameron) and FAILONGE(P CRICH) began awkwardly.

GILT PRINCE (B Carlile) raced wide without cover throughout the event.

Subsequent to this event B Carlile reported to the Stewards that her mount hung out from about the 700 metres to the 300.

Shortly after the gates opened, GIVE ME SOME (S Westover) was inclined to get its head up and race ungenerously for about 400 metres.

The details of the charge being that when he rode SKYCON! he used his whip in a forehand manner in consecutive strides and 4 times more than the permitted 5 prior to the 100 metres.

Stewards ordered that C Moon forfeit his riding fee for this event (AR196(2)).
