RACE 1 0-70 HANDICAP 1200 METRES:

As K Manoukian was indisposed (injured) the following rider changes were made;

Race 1 C Moon

Race 2 M Hart

Race 3 R Vigar

Race 4 J Cameron

As the gates opened, AGAINST THE DAY (M Evans) was slow into stride.

1ST LET'S TRY LONGER 2ND MISS ICELAND 3RD AGAINST THE DAY

RACE 2 0-58 HANDICAP 1100 METRES:

As the gates opened, METRO (P Johnson) was tightened momentarily between runners whilst LOUDEST (R Vigar) jumped a little awkward.

GODLIKE (S Evans) was fractious in the barriers.

Approaching the 700 metres, JOHN'S CHOICE (K Connor) had to steady off the heels of GODLIKE.

Subsequent to this event, R Vigar the rider of LOUDEST was reprimanded under AR.137A(5)(a)(i)(ii) in that he used his whip in a forehand manner on 9 occasions prior to the 100 metres, 7 strokes being consecutive.

1ST RAMPANT PRINCE 2ND DANCINGONTHEPEAK 3RD AFTONLAND

RACE 3 0-64 HANDICAP 1600 METRE:

Approaching the 200 metre mark, THEISM (M Evans) which was running on strongly, shifted out quickly and momentarily unbalanced its rider.

Subsequent to this event R Vigar, rider of FAYEZEE was found guilty of a charge under AR.137A(5)(a)(i)(ii) in that he used his whip in a forehand manner on 8 occasions prior to the 100 metres, 4 strokes being consecutive.

Acting under AR.196(2), Stewards ordered that R Vigar forfeit his riding fee for this event.

RACE 4 3YO BENCHMARK 54 HANDICAP 1400 METRES:

As the gates opened both TROBAR (R Vigar) and BELLANICIO (M Evans) stood flat-footed and lost ground whilst LANOGATCO (S Evans) jumped a little awkward.

LANOGATCO was inclined to race a little green down the length of the straight.
