RACE 1 0- 70 HANDICAP 1200 METRES:

As the gates opened, SINGLE COMMAND (K Manoukian) and THEISM (S Evans) were slow into stride.

1ST PRINCE OF HOPE 2ND SCAT SINGER 3RD CARDHU MALT

RACE 2 MAIDEN PLATE 1200 METRES:

M Hart rider of MELLY SCHILLER was dislodged on the way to the barriers.

MELLY SCHILLER subsequently underwent a veterinary inspection at the barriers and was passed fit to start.

As the gates opened, HIGH PATROL (S Evans) and MELLY SCHILLER made contact. Shortly after jumping, GODLIKE (K Manoukian) was momentarily tightened between runners.

Subsequent to this event E Brooks rider of PERFECTNESS was issued with a reprimand by stewards for using her whip when her mount was out of contention (AR137A(4)(c)).

1st GODLIKE 2ND SILENT ROCK 3RD NORTHERN EDGE

RACE 3 0-58 HANDICAP 1000 METRES:

LETS TRY LONGER was a late scratching at 3:17 after its rider C Johnson failed to fulfil his riding engagement and no other rider was available on course.

As the gates opened, BECKETT WAY (B Hoppo) jumped a little awkwardly and commenced to shift in slightly whilst VO JESTER (K Gladwin) reared and was slow away.

OUTLOOK EXPRESS (E Brooks) raced wide through out the event without cover. T Gillett trainer of NOVADANTE was fined \$20 for the use of the clubs colours (LR121). T Gillett was fined \$100 in that he presented his runners GENARKA STAR and NOVADANTE late into the mounting yard (AR124).

B Hoppo rider of BECKETT WAY was fined \$100 for misconduct in that he struck his mount with his whip post-race in the mounting yard (AR87(a)).

M Hart rider of WESTERN REBEL was found guilty of a charge under AR137A(4)(g) in that he used his whip on his mount when it was clearly winning.

Stewards acting under AR196(2) ordered that M Hart forfeit his riding fee for that event. All monies invested on LET'S TRY LONGER withdrawn by order of the stewards at 3:17 to be refunded.

Deductions applicable to the bets placed on the winner and place-getters prior to 3:17:-
For the winner 9 cents the win, 12 cents the place, for 2nd 12 cents, 3rd 10 cents.

1ST WESTERN REBEL 2ND LOUDEST 3RD GENARKA STAR

RACE 4 BENCHMARK 70 HANDICAP 1000 METRES:

As the gates opened, DEAL BROKER (C Moon) was slow into stride.

1ST CONCINI 2ND PRINCESS ZIETTA 3RD SILENT MOTIVE

RACE 5 0-64 HANDICAP 1400 METRES:

As the gates opened, MIRON (M Evans) jumped awkwardly making contact with AUSBRED ROYAL (C Moon) on its inside which was a little slow into stride.

Rounding the first turn, THE SNITCH (K Gladwin) raced wide.

DAY DIVA (E Brooks) was inclined to lay out throughout the event.

1ST MIRON 2ND DAY DIVA 3RD HIDDEN TEARS
