### RACE 1 0-58 HANDICAP 1200 METRES:

HE'S REELING (J Brown) was a late scratching from this event at 2:26 on Veterinary advice after the gelding took charge of its rider and galloped a circuit of the track.

As the gates opened, PERRFECT COCKTAIL (A Cavallo) knuckled slightly.

STORMY REBEL (C Forrest) raced wide rounding the home turn.

ALL RILED UP (K Connor) was inclined to roll out under pressure over the concluding stages of the event.

All monies invested on HE'S REELING withdrawn by order of the stewards on veterinary advice at 2:26 to be refunded.

Deductions applicable to the bets placed on the winner and place-getter prior to 2:26:-  
2 cents in the dollar for the win, 4 cents the place, 2<sup>nd</sup> 5 cents, and 3<sup>rd</sup> 5 cents.

### RACE 2 0-70 HANDICAP 1200 METRES:

C Johnson replaced C Quilty as the rider of TRISTA RULER after that rider became indisposed.

As the gates opened, both MEGA MISS (R Vigar) and PRIVATE DOWNS (P Denton) were slow into stride.

Subsequent to this event, K Connor rider of CAPACITATE was found guilty of a charge under AR137A (5)(a)(ii).

The details being that prior to the 100 metres, she used her whip in a fore-hand manner on 8 occasions, 3 extra strikes being in contravene of AR137A5(a)(ii).

Stewards acting under AR196 (2) ordered that K Connor forfeit her riding fee and winning percentage for this event.

GODSHIP (P Denton) was inclined to lay out over the concluding stages of the event. RANDI was inclined to lay out throughout the event.
